RECENT ACCOMPLISHMENTS

- 100% Tuition Reimbursement under Minnesota Stature 192.501 Financial incentives for National Guard members. Tuition and Textbook Reimbursement grant program. If a member of the Minnesota National Guard is killed in the line of state active service or federally funded state active service the member’s surviving spouse, and any surviving dependent who has not reached 24 years of age is eligible for a tuition and textbook reimbursement grant.
- Homeowners insurance protection that guarantees no insurer can refuse to renew, reduce the limits of coverage, or cancel or charge a differential rate if the


dwelling is vacant or unoccupied by a caretaker due solely to the insured being called to active duty.

- A new “Support Our Troops” license plate available. Proceeds will go to Veteran’s programs and for emergency relief for military members of Minnesota and their families.
- An extension of the MN National Guard tuition reimbursement program whereby members who have been called to active service will receive an additional 2 years plus the time of deployment to use the Program following discharge from the National Guard. For those National Guard members discharged due to service connected illness or injury, the extension is for a period of 8 years.

PREVIOUS ACCOMPLISHMENTS

- Frequent pay raises.
- Establishment & extension for the VA Home Loan For Guard & Reserve members.
- DOD Dental insurance plans for Retirees and National Guard members.
- Burial benefits for National Guard members.
- Increase in Commissary visits for Guard and Reserve members.
- Small Business Administration loans for mobilized Guard & Reserve members.
- Retention of 4-pay periods for a UTA weekend – (Senate & Congress is trying to allow for only 2-pay periods).
- Retention of the 15-day military leave for federal civilian employees when it was slated for elimination twice.
- Retirement flags for retiring Guard & Reserve members.
- Increase in IDT points that can be earned in one year from 60 to 75 to 90.
- AGR retirement at highest grade held.
- Imminent Danger Pay equity.
- Montgomery GI Bill education benefits increase & improvements.
